

Golf Carts (Certificate of Liability Insurance Required).

Maximum of 2 drivers permitted. Drivers will be required to sign an agreement at RM office before driving. See below.

Golf Cart Rental(s) Agreement

Conditions:

- You must be at least 21 years of age, have a valid driver's license, and have a Certificate of Liability Insurance on file (or provide valid homeowner's/renter's insurance). Only one additional driver may be added per rental agreement. Golf cart operators are responsible for any damage to personal property or injury to individuals that result from accidents involving the golf cart they are operating.
- Golf carts can transport a **maximum of 4 persons (children under 3 may be a fifth rider)**. Maximum weight is 400 lbs. in front and 300 lbs. in back.
- Drive VERY SLOWLY. Reckless driving, racing, horse play, and/or other irresponsible use of the golf cart(s) will not be tolerated. **No warnings will be given.** Any RM Staff member who observes a violation is REQUIRED to pull the keys and turn them into the office. The keys will not be returned until the driver speaks with the Office Manager.
- Golf carts must be operated on paved/stone roads. Do not drive on grass or walking paths.
- Golf carts operating after sunset must have the lights turned on.
- Refreshing Mountain has many hills, so if you park on a hill, park so that you are NOT facing uphill or downhill. (See pictures). Always set the parking brake.

Terms

- 1. The initial rental includes one full tank of gas. Additional tanks of gas must be purchased from RMC at market cost.
- 2. A \$30.00 charge will be billed for any lost keys.
- 3. A credit card must be placed on file with RMC, for use as a deposit for the vehicle. The credit card shall be used as deposit on the vehicle for up to \$600.00, and additional expenses (i.e. fines, costs for repair of damages, etc.), with an unspecified maximum, may be levied against the card if warranted.
 - a. If rented by an Organization hosting a retreat at RMC, the security deposit and Insurance Certificate may be used in lieu of a credit card.

Legal:

The undersigned, being an authorized representative of the Organization/Individual (hereafter *Renter*) renting the golf cart, understands and agrees to the following:

- 1. All of the conditions pertaining to use of golf carts, as listed by Refreshing Mountain Camp, Inc. and attached to this agreement, shall be strictly adhered to. Failure to do so shall, at the discretion of the staff of Refreshing Mountain Camp, Inc., be grounds for immediate termination of the rental without refund.
- 2. It shall be assumed that those operating the golf cart during this rental period have received permission from the *Renter* to do so and have attended an instructions session at the Camp Office. Therefore, the *Renter* accepts all responsibility and all liability for any and all actions of operator of the golf cart for the duration of this agreement.
- 3. All fees for rental and fines for misuse of the golf cart (as attached to this agreement) are acceptable to the *Renter*. Additionally, any unspecified costs that arise from use/misuse of the golf cart, including, but not limited to damage to the golf cart, damage to property, injury to person(s), etc., shall be the sole responsibility of the Renter.
- 4. Renter agrees to indemnify and hold Refreshing Mountain Camp, Inc., its employees, shareholder, Board of Directors, and other affiliates, harmless from any and all loss, liability and/or expense of any kind and nature incurred by and/or asserted against the Renter arising in any manner from this agreement.
- 5. Renter hereby disclaims any representation or warranty, either expressed or implied, as to any manner whatsoever, including without limitation, the design, performance, specifications, and/or condition of the equipment, its merchantability or the fitness for any particular purpose, the quality of the material or workmanship of the equipment.
